#### 214. DR. BHARATIBEN DHIRUBHAI SHIYAL:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) whether the Government provides any assistance to the farmers for promoting pisciculture; and
- (b) if so, the amount of funds provided as assistance during the current year and the last three years, State-wise, including Gujarat?

#### **ANSWER**

### THE MINISTER OF STATE FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI PRATAP CHANDRA SARANGI)

(a) and (b): Yes, sir. The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying under the Pradhan Mantri Matsya Sampada Yojana (PMMSY)- 'A scheme to bring about Blue Revolution through sustainable and responsible development of fisheries sector in India' provides financial assistance for pisciculture activities covering inland fisheries and aquaculture, marine fisheries including mariculture, seaweed cultivation, ornamental fisheries and recreational fisheries, cold water fisheries, open sea cage culture, installation of cages in reservoirs, Re-circulatory Aquaculture System (RAS)and Biofloc culture system. The State/UT-wise details of funds released by the Department of Fisheries for development of fisheries during last three years under erstwhile Blue Revolution Scheme and first installment of central share released during the current year (2020-21) under PMMSY including the State of Guiarat is furnished at Annexure I.
