Fellowship scheme for girls

2169. SHRI BALASHOWRY VALLABHANENI:

Will the Minister of *Education* be pleased to state:

- (a) the provision was made earlier to enroll more and more girls into IITs and ultimately achieve 20 per cent enrolment by 2019-20;
- (b) if so, the details thereof and if not, the reasons therefor;
- (c) whether there is any proposal to extend the enrolment year to 2022 and the steps being taken by the Government to push research among girl students from IITs and IIITs;
- (d) whether the Government is proposing any special Fellowship scheme for girls studying in these institutes;
- (e) if so, the details thereof and, if not, the reasons therefor; and
- (f) the details of funds sanctioned for IITs and IIITs in the country, with a particular reference to Andhra Pradesh during the last five years and for 2021-22?

ANSWER

MINISTER OF EDUCATION (SHRI RAMESH POKHRIYAL 'NISHANK')

(a) & (b) : With a view to improve female enrollment in the Indian Institutes of Technology (IITs), the Government had decided to increase female enrollment in the B.Tech. programmes of IITs from 8% to 14% in 2018-19, 17% in 2019-20 and 20% in 2020-21 by creating supernumerary seats. Necessary instructions in this regard were issued to all the IITs for compliance. Against these, the female enrolment in IITs for B. Tech. Programmes was 15.3% in 2018-19, 18% in 2019-20 and 19.8% in 20-21.

(c) to (e): The female enrolment of 19.8% has already been achieved in IITs. The girls are getting fellowship at par with male students in the IITs and IIITs (CFTIs).

(f) : The details of funds released to IITs and IIITs in the country, with a particular reference to Andhra Pradesh during the last five years and for 2021-22 are as under-
