- (a) the details of total number of beneficiaries of Skill Loan Scheme in the country till date, State-wise; and
- (b) the total amount of funds sanctioned under the said scheme till date?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI R.K. SINGH)

(a) & (b): The Government of India had launched Skill Loan Scheme on 15th July, 2015 to provide loan facility to aspirants wanting to do skill development courses aligned to National Skill Qualification Framework (NSQF). Any Indian National who has secured admission in a course run by Industrial Training Institutes (ITIs), Polytechnics or in a school recognised by Central or State education Boards or in a college affiliated to recognised university, training partners affiliated to National Skill Development Corporation (NSDC), Sector Skill Councils, State Skill Mission, State Skill Corporation etc. can avail loan for the purpose. Amount of loan varies from Rs. 5,000 to Rs. 150, 000/- depending on the course and has a repayment period of 3 to 7 years. The State-wise and Union Territory-wise details of number of beneficiaries and amount sanctioned under the scheme are given at **Annexure**.
