2410. MS. DIYA KUMARI:

Will the Minister of **SOCIAL JUSTICE AND EMPOWERMENT** be pleased to state:

- (a) the details of funds sanctioned, disbursed, and utilized during the last three years for the implementation of Pradhan Mantri Adarsh Gram Yojana (PMAGY) in Rajasthan, district-wise; and
- (b) the details of the indicators used to monitor the categorization of villages under PMAGY?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI RATTAN LAL KATARIA)

- (a): The district-wise details of funds sanctioned by the Ministry under the Pradhan Mantri Adarsh Gram Yojana (PMAGY) in the last three years and disbursed to the districts of Rajasthan by the State Government, are at **Annexure-I**. The districts have not utilised these funds so far.
- (b): There is no system of categorization of villages under PMAGY. However, the needs and gaps in the selected villages are assessed, and progress of implementation of the scheme is monitored, against 50 identified Monitorable Indicators in 10 Domains which are as under:
- i) Drinking water and Sanitation
- ii) Education
- iii) Health and Nutrition
- iv) Social Security
- v) Rural Roads and Housing
- vi) Electricity and Clean Fuel
- vii) Agricultural Practices etc.
- viii) Financial Inclusion
- ix) Digitization
- x) Livelihood and Skill Development.
