- (a) The details of the different agricultural produce like wheat, paddy etc. which have been sold above Minimum Support Price (MSP) after the promulgation of the ordinances and consequent enactment of the three new farming laws, product-wise and State/UT-wise;
- (b) the details of the total production, requirement and consumption of different food products including edible oil in the country during the last two years and the current year, product-wise;
- (c) the details of the total quantity of food products including edible oil which have been exported from the country during the last two years and current year; product-wise; and
- (d) the details of the total quantity of food products including edible oil which have been imported into the country during the last two years and the current year, productwise?

However, the details of Gross Value Added of different food products including edible oil in the country for the year 2015-16 to 2017-18, as per as per latest data available from the Annual Survey of Industries released by Ministry of Statistics and Programme Implementation(MoSPI) for registered sector is at **Annexure-II**.
- (c) & (d): The details of export and import of total food products including edible oil of the country during the last two years and current year in terms of value are at **Annexure-III and Annexure-IV** respectively.
