CEFPPC SCHEME

2429. SHRI MANICKAM TAGORE B.:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government has implemented the scheme of Creation and Expansion of Food Processing and Preservation Capacities (CEFPPC) under the Pradhan Mantri Kisan Sampada Yojana (PMKSY) with the aim of creating 28 food processing projects in States including Tamil Nadu;
- (b) if so, the details of this project alongwith the expected capacity of food processing of these projects; and
- (c) the details of funds allocated for this purpose and the time limit fixed by the Government for the execution of the project?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI RAMESWAR TELI)

(a) to (c): Ministry of Food Processing Industries (MoFPI) is implementing a Scheme for Creation/Expansion of Food Processing & Preservation Capacities (CEFPPC) under the Pradhan Mantri Kisan Sampada Yojana (PMKSY) for setting up / expansion of food processing industries in the country including Tamil Nadu. Under the scheme, grants-in-aid @ 35% of the eligible project cost is provided in General Areas and 50% of the eligible project cost in North Eastern States including Sikkim and Difficult areas including Himalayan States (Himachal Pradesh, J&K & Uttarakhand), notified Integrated Tribal Development Projects (ITDP) areas, Islands and Scheduled Caste (SC) / Scheduled Tribe (ST) promoter(s), subject to a maximum of Rs. 5.00 crore.

The food processing units can be setup in Mega Food Parks (MFPs) and Agro Processing Clusters (APC) assisted by the Ministry from time to time. However, in States / UTs having no MFP or APC, the food processing units may be setup anywhere in that State / UT. Further, the units having 100% shareholding of SC / ST promoter(s) and with an eligible project cost of more than Rs. 1.00 crore can be set up at any location in the country.

Till date, 22 food processing units have been approved / sanctioned under the CEFPPC Scheme in State of Tamil Nadu. The details of these units along with expected capacity is at **Annexure**.

The revised Budget allocation for CEFPPC Scheme is Rs. 1068.50 crore. As per extant scheme guidelines, the implementation schedule for the projects is 18 months from the date of issue of approval letter.
