# FARM PENSION AND INSURANCE BENEFICIARIES

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) the number of farmers who have received the benefit of old age pension under Pradhan Mantri Shram Yogi Mandhan Yojana in the State of Haryana; and

(b) the number of farmers who have been provided insurance cover under Pradhan Mantri Fasal Bima Yojana in Sonipat, Haryana in case of loss of their crops due to floods along with the details thereof?

# ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) : In order to provide old age protection to unorganized sector workers, the Government of India has launched a flagship scheme namely, Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) in March, 2019, which is a voluntary and contributory pension scheme. The workers in the age group of 18-40 years whose monthly income is Rs. 15000/- or less and not a member of Employee Provident Fund Organization (EPFO)/Employees' State Insurance Corporation (ESIC)/(National Pension Scheme (NPS) can join the scheme. Under the scheme, 50% monthly contribution is payable by the beneficiary and equal matching contribution is paid by the Central Government. Each subscriber under the PM-SYM, shall receive minimum assured pension of Rs 3000/- per month after attaining the age of 60 years. As on 22.02.2021, over 8.94 lakh persons including farmers have been registered under the scheme in Haryana.

(b) : Pradhan Mantri Fasal Bima Yojana (PMFBY) has been introduced from Kharif 2016 to provide a simple and affordable crop insurance product to ensure comprehensive risk cover for crops of farmers against all non-preventable natural risks from pre-sowing to post-harvest and timely settlement of claims. Haryana Government is implementing the scheme since its inception. As the major part of the scheme is being implemented on Area Approach basis and season-end claims are worked out on the basis of yield data submitted by the concerned State Government, therefore, reasons for crop loss/ claims are not looked into or not known. Hence, risk/peril-wise details i.e. due to flood, drought, pest attack, etc., of claims are not maintained for wide spread calamities/season-end claims under the

scheme. Season-wise/Year-wise details of coverage including claims paid in Sonipat district under the scheme are given in following table :
