Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the Government provides free assistive aids and devices to divyangs by organising special camps at district level; and
- (b) if so, the details thereof alongwith the names of the districts of Jharkhand where the said camps have been organised or proposed to be organised?

ANSWER

- (a) Yes Madam. Under the 'Assistance to Disabled Persons for Purchase/Fitting of Aids and Appliances' (ADIP) Scheme, special camps are organized at district level throughout the country on the requests of Members of Parliament and other dignitaries or as per requirement/demand from District/State authorities.
- (b) During the last six years and current year, 686 special camps have been organized across the country wherein aids and assistive devices amounting to Rs.517.88 crore were distributed to 6.07 Lakh beneficiaries.

Holding of camps for distribution of aids and assistive devices under the Scheme is a continuous activity. Being a Central Sector Scheme, camps are held in the States/Uts across the country including Jharkhand, based on the requirement and demand in a particular district.

The details of camps organized in the districts of Jharkhand under the Scheme during the last six years and the current year are at Annexure.
