Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the details of funds allocated for various schemes of food processing industries(FPI) during the last three years, State-wise;
- (b) the details of funds released under various schemes of FPI sector during the last three years, State-wise, including Jharkhand; and
- (c) the details of utilized/unutilized funds under various schemes of FPI sector during the last three years, State-wise?

ANSWER

(SHRI RAMESWAR TELI)

(a) to (c): Ministry of Food Processing Industries (MoFPI) is implementing Central Sector umbrella scheme - PRADHAN MANTRI KISAN SAMPADA YOJANA (PMKSY) for overall growth and development of food processing sector across the country (including the State of Jharkhand). The scheme components of PMKSY are demand driven, under which credit linked capital subsidy in the form of grant-in-aid is provided to eligible applicants. The Scheme wise allocations made under PMKSY and funds utilized during last three years(2017-18, 2018-19 and 2019-20) and the current financial year i.e. 2020-21 (till 26.02.2021) is placed at Annexure.

Also, as part of Aatmanirbhar Bharat Abhiyan, MoFPI has launched an all India centrally sponsored "PM Formalization of Micro food processing Enterprises (PMFME) Scheme" for providing financial, technical and business support for upgradation of two lakh micro food processing enterprises in a period of five years from 2020-21 to 2024-25 with an outlay of Rs. 10,000 crores, out of which 5468 units have been allocated to the state of Jharkhand with an outlay of 250.33 Crore for next five years. State-wise funds released under the scheme is placed at **Annexure**.
