RURAL DEVELOPMENT WORKS IN CHHATTISGARH

2509. SHRI SANTOSH PANDEY:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the funds allocated for development of rural areas in Chhattisgarh during each of the last three years and the names of works on which the fund has been spent; and
- (b) the funds allocated and utilised from the year 2019 till date in Chhattisgarh, particularly in Rajnandgaon and Kabirdham districts?

(a) & (b) The Ministry of Rural Development (MoRD) is implementing Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS), Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY), Pradhan Mantri Awaas Yojana – Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), National Social Assistance Programme (NSAP), Shyama Prasad Mukherji Rurban Mission (SPMRM) and Saansad Adarsh Gram Yojana(SAGY) to bring about overall improvement in the quality of life of the people in rural areas, strengthening of livelihood opportunities, promoting self-employment, skilling of rural youths, infrastructure development, provision of social assistance and other basic amenities.

The details of allocation/ utilization/ expenditure incurred under difference schemes of MoRD to Chhattishgarh and the districts of Rajnandgaon and Kabirdham for the financia years 2018-19, 2019-20 and 2020-21 are at **Annexure**. However, DDU-GKY and RSETI Schemes are demand driven schemes and funds are allocated to States as per demands against approved Action Plans. No district/region-wise allocation of funds is made under both the schemes. Similarly, Mahatma Gandhi NREGS is also a demand driven scheme and no separate allocation to the State/district is made. Under the Saansad Adarsh Gram Yojana framework, the development of Gram Panchayats is envisaged through convergence and implementation of existing Government Schemes and Programmes under the administrative control of respective Ministries without allocating additional funds. Under NSAP funds are allocated to States but no district wise allocation is made. Under SPMRM, funds are being released to the States/ UTs based on fulfillment of certain conditions mentioned in the Mission guidelines. Under SPMRM in Rajnandgoan district of Chhattishgarh, one Tribal cluster Murmunda has been indentified and in Kabirdham district, two Non-Tribal clusters namely, Birkona and Kunda have been identified. Under DAY-NRLM, funds are released to the States and not to the districts which is done by the State. Under PMGSY, funds are released to the State as a whole as per annual allocation depending upon the absorption capacity of the State and does not release funds to the district directly.

1. Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS)

The details of fund released by Central Government to State of Chhattisgarh, expenditure incurred and works completed in Chhattisgarh under Mahatma Gandhi NREGS during the last three years are as under:

The works on which, the fund has been spent under the MGNREGA are: Public works relating to natural resources management, community assets or individual assets for vulnerable sections, common infrastructure including for NRLM compliant Self Help Groups and Rural Infrastructure.

Central Government does not release funds directly to the Districts under MGNREGA. However, the details of the expenditure in Rajnandgaon and Kabirdham(Kawardham) districts of Chhattisgarh under MGNREGA is given below:-

The works on which, the fund has been spent under the SPMRM are: Access to village streets with drains, Citizens service centres, Digital Literacy, Education, Employment generation and SHG formation, Piped water supply, Solid and liquid waste management, Sports infrastructure, Village street lights and electrification etc.

The funds are released to state as a whole as per the annual allocation and depending upon the absorption capacity of state. Further utilization of funds are made by the state government depending upon the various stages of road works sanctioned and under progress.
