#### **HENLEY GLOBAL PASSPORT INDEX**

### 254 SHRI RAJIV PRATAP RUDY:

Will the Minister of External Affairs be pleased to state:

- (a) whether India's rank on the Henley Global Passport Index has reduced in the latest edition of the rankings;
- (b) if so, the reasons therefor;
- (c) the details of the steps being taken by the Government to boost India's ranking on the Henley Global Passport Index;
- (d) the list of countries that guarantee Visa-Free access or Visa-onarrival to visiting Indian nationals along with the status of reciprocal access: and
- (e) whether the Government is negotiating with other countries on improving the strength of the Indian Passport and if so, details thereof?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS [SHRI V. MURALEEDHARAN]

- (a) As per information available on the website <a href="https://www.henleypassportindex.com">www.henleypassportindex.com</a>, the Henley Passport Index ranks all the passports of the world according to the number of countries their holders can travel to visa free. The ranking is based on exclusive data from the International Air Transport Association and lists the countries that can be accessed visa-free, with an electronic visa [e-TA] or with a Visa-on-Arrival. As per the Henley Passport Index available on the website for Q1 2021, India is ranked at 85.
- **(b), (c) & (d)** Extension of Visa free entry and Visa-on-Arrival is a unilateral decision of the receiving country. The Government has been continually making efforts to increase number of countries that may provide Visa free travel and Visa-on-Arrival facilities with an objective of further increasing the number of countries extending Visa free and Visa-on-Arrival facilities to Indian nationals and also in promoting investments and tourism into India from other countries.

There are 16 countries which provide Visa-free entry to Indian passport holders (List enclosed as Annexure-I) and 43 countries which

provide Visa-on-Arrival facility to Indian Passport holders (List enclosed as Annexure-II).

**(e)** While issuance of visa and visa related process is the sovereign and unilateral decision of the respective country, the matter regarding easier and liberalized visa policy for Indian nationals is taken up regularly in bilateral meetings/ forums with foreign countries.
