- (a) whether the Government has any data with regard to the IAS and IPS presently in service and if so, the details thereof, State/UT-wise;
- (b) whether the Government has any data with regard to the departmental complaint/cases registered against IAS/IPS during the last five years (including financial and criminal cases);
- (c) if so, the State and UT-wise details of last five years thereof along with the action taken by the Government against the guilty officials; and
- (d) if not, the reasons therefor?

## MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE (DR. JITENDRA SINGH)

- (a): The cadre-wise Total Authorized Strength of IAS and IPS (as on 01.01.2020) along with officers in service is given at Annexures "A" and "B" respectively.
- (b): In respect of IAS officers, the data relating to number of complaints State-wise is not maintained centrally. However, the total number of complaints against IAS officers received by the Central Government during last five years is as under:

(c) & (d): In terms of AIS (D&A) Rules, 1969, if at the time of misconduct, the officer was serving under the State Government, State Government concerned is the authority competent to take departmental action against an IAS/IPS. If at the time of misconduct the officer was serving under the Central Government, action against him is taken by the concerned cadre controlling authorities viz Ministry of Home Affairs for IPS and Department of Personnel & Training for IAS.
