- (c) whether the Government has plan to expand the scheme to all schools in the country; and
- (d) if so, the details thereof and if not, the reasons therefor?

- (a) & (b) The information pertaining to the amount spent on Atal Tinkering Labs (ATLs) under Atal Innovation Mission (AIM) per state from the inception of the scheme till date; and the details of the number of school that have ATLs, statewise and distribution of such labs in Government and Private schools; is placed at <u>Annexure A.</u>
- (c) Currently, AIM has no plan to expand the scheme to all schools in the country, as per budgetary mandate.
- (d) The mandate of the Atal Innovation Mission is to set-up and establish 10,000 ATLs in schools across the country. The selection of 10,000 schools for the establishment of ATL is done and till date, 7138 schools have received the ATL Grant-in-Aid.
