A total of 440 Block Level Clusters have been sanctioned under National Handloom Development Programme (NHDP) and Comprehensive Handloom Cluster Development Scheme (CHCDS) in the country since 2015-16. State-wise details of Block Level Clusters sanctioned are annexed.
