HOUSING OF CGHS DISPENSARY IN RENTED BUILDINGS

2888. SHRI GIRISH BHALCHANDRA BAPAT:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether a number of CGHS Wellness Centres are housed in rented buildings in the country including CGHS dispensary (D-91) in Kishangarh;
- (b) If so, the details thereof; and
- (c) the time by which such dispensaries including the said dispensary in Kishangarh are likely to be shifted to their dedicated permanent buildings?

(a) to (c): Out of a total of 420 Wellness Centres under Central Government Health Scheme (CGHS), 124 Wellness Centres are functioning in rented buildings including the Wellness Centres (D-91) at Kishangarh, Delhi. A statement showing such CGHS Wellness Centres housed in rented buildings is at **Annexure**.

Shifting of Wellness Centres to their permanent buildings depends on the availability of suitable land/ building and other resources. This is a continuous process. Efforts are made to ensure that neither CGHS beneficiaries nor Medical Officers/ employees at Wellness Center(s) face inconvenience.
