### STANDADIZATION OF AYURVEDIC MEDICINES

### 2897. SHRI RAJENDRA AGRAWAL:

Will the Minister of AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) be pleased to state:

- (a) whether the Government has taken any steps for standardization of Ayurvedic medicines and practices in the country;
- (b) if so, the details thereof, State/UT-wise; and
- (c) if not, the reasons therefor?

## **ANSWER**

# THE MINISTER OF STATE (IC) OF THE MINISTRY OF YOUTH AFFAIRS AND SPORTS AND ADDITIONAL CHARGE OF MINISTER OF STATE (IC) OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI KIREN RIJIJU)

- (a) & (b): The Government has established Pharmacopoeia Commission for Indian Medicine and Homoeopathy under the Ministry of AYUSH. The prime mandate of the Commission is to publish and revise Ayurvedic Pharmacopoeia of India (API), Siddha Pharmacopoeia of India (SPI), Unani Pharmacopoeia of India (UPI) and Homoeopathic Pharmacopoeia of India (HPI). The Pharmacopoeial standards are basic need to ensure quality, safety and efficacy of Ayurvedic, Siddha, Unani and Homoeopathic medicines. The Pharmacopoeia Commission is also responsible to publish and revise Ayurvedic, Siddha and Unani official formularies and regulatory compendiums in respect of quality standards of AYUSH drugs under the Drugs & Cosmetics Act, 1940 and Rules, 1945 to regulate the quality of these drugs.
- So far Government has published Ayurvedic pharmacopoeia contains 645 monographs of single drugs and 202 monographs of compound formulations; Unani Pharmacopoeia contains 351 monographs of single drugs and 150 monographs of compound formulations; Siddha pharmacopoeia contains 139 monographs of single drugs and Homeopathic Pharmacopoeia contains 1117 monographs. The Ayurvedic formulary of India contains 985 formulation, National formulary of Unani medicines contains 1229 formulation and Siddha formulary of India contains 399 formulation.
