- b. the amount of revenue received through verification of vehicles during the said period and the number of cases including the amount involved for which show cause notices were issued;
- c. the number of vehicles owned by the department and the vehicles hired on contract during the last three years and whether all the vehicles are being operated in compliance with all the guidelines fixed by the Government of India/Regional Transport Office along with the amount of funds spent on these vehicles; and
- d. the number of vehicles out of the said vehicles deployed for e-way bill checking and the number of commercial vehicles out of the same including the number of vehicles in which GPS system is installed?
