## **VACANCIES IN ICAR**

3450. SHRI P.C. GADDIGOUDAR: SHRI RAVNEET SINGH BITTU:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि और किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government is aware that over 1,000 posts of scientists and over 2,100 technical posts are lying vacant in Indian Council for Agricultural Research (ICAR);
- (b) if so, the details thereof including the complete information of sanctioned posts and actual strength in various grade of scientists and other technical posts in ICAR;
- (c) whether it is a fact that the shortfall of technical personnel in ICAR can have serious repercussions on the research activities of the Institute;
- (d) the extent to which the shortfall has adversely affected the research activities of ICAR;
- (e) whether any steps are being taken by the Government to enable the early filling up of the vacant posts in ICAR; and
- (f) if so, the details thereof and if not, the reasons therefor?

## ANSWER

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि और किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) & (b): Out of the total sanctioned strength of 6586 positions in scientific cadre in ICAR, 1504 are vacant. Likewise, out of the total sanctioned strength of 6756 in case of technical cadre 2311 are vacant. Cadre and category wise details are as under:-

(e) & (f): The recruitment of scientific and technical positions is a continuous process and the vacancies are filled up through an established procedure by the Agricultural Scientist Recruitment Board (ASRB) or the Institute subject to availability of qualified candidates. The vacancy position is monitored regularly within ICAR and with ASRB towards timely selection and deployment of human resource.
