- (a) whether the Government has implemented Deen Dayal Disabled Rehabilitation Scheme (DDRS) in Bihar;
- (b) if so, the numbers of schools and vocational training centres provided with grants under this scheme during the last three years and the current year, year-wise;
- (c) the number of proposals sent by the State Government of Bihar for Deen Dayal Disabled Rehabilitation Scheme so far;
- (d) the details and the number of such proposals which got approval for administrative and financial aid, proposal-wise; and
- (e) whether some proposals have not been approved and if so, the reasons for non approval of the same?

(a) Yes, Sir. The Government is implementing Deendayal Disabled Rehabilitation Scheme (DDRS), under which financial assistance is provided to Non-Governmental Organisations (NGOs) for promoting the welfare of Persons with Disabilities (PwDs) in the Country including the State of Bihar.
