# LOK SABHA UNSTARRED QUESTION NO. 3702 TO BE ANSWERED ON 18/3/2021

#### TAP WATER UNDER JJM

#### 3702. SHRI KESINENI SRINIVAS:

Will the Minister of JAL SHAKTI be pleased to state:

- a) the break-up of the percentage of households provided tap water under the Jal Jeevan Mission in Andhra Pradesh, district-wise;
- (b) whether a functionality assessment was made for the State of Andhra Pradesh and if so, the details thereof; and
- (c) whether an alternative mechanism is set up for delivery monitoring for households that do not have an Aadhar Number and if so, the details thereof?

#### **ANSWER**

## MINISTER OF STATE FOR JALSHAKTI (SHRI RATTAN LAL KATARIA)

- (a) The district-wise percentage of households provided tap water connections since launch of Jal Jeevan Mission (JJM) and percentage of total rural households having tap water supply as on 16.3.2021 in Andhra Pradesh, is **annexed.**
- (b) During 2020-21, the functionality assessment of tap water connections has been commissioned. The field survey has been completed and assessment report is under finalization. Earlier, a functionality assessment of drinking water supply schemes was carried out in 2018-19, wherein 94.79% drinking water supply schemes in Andhra Pradesh were found functional.
- (c) Operational Guidelines for the implementation of JJM stipulates that, for targeted delivery and monitoring of specific outputs, Functional Household Tap Connections (FHTC) is to be linked with the Aadhaar number of the head of the household, subject to statutory provisions. As per Gazette notification dated 24.02.2020, an individual will be required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication, except in the States of Assam and Meghalaya.
