Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) Whether the Government has proposed to conduct training programme on 'Track Child Portal' under the child safety plan
- (b) if so, the time by which the said training programme is likely to be organized in the country along with names of such places where the above training programmes have been conducted during the last three years, State-wise including Maharashtra; and
- (c) the total number of officials trained under the said programme; and the outcome of said training programme thereof?

(a) to (c): The Ministry of Women and Child Development (MWCD) has developed web portal "TrackChild" to track the missing and found children. The TrackChild Portal is implemented involving various stakeholders including Ministry of Home Affairs (MHA), Ministry of Railways, State Governments/UT Administrations, Child Welfare Committees, Juvenile Justice Boards, National Legal Services Authority, etc. The details of the officers trained under the said programmes are not maintained by this Ministry. As per information provided by the National Informatics Centre, the details of training programmes held is **Annexed**.
