Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the Government has adopted Gender Budgeting (GB) in order to strategize gender mainstreaming across sectors and at all levels of governance in the country, if so, the details thereof indicating the current status and progress made in this regard;
- (b) the funds allocated/released to Central/State Government/Autonomous Institution for mainstreaming gender concern during the last three years;
- (c) whether the gender responsive budgeting statement has any impact on actual allocation of funds during the project design phase and if so, the details thereof and if not, the reasons therefore;
- (d) whether all the State Governments/UTs have adopted Gender Budgeting and if so the details thereof, if not, the details of State Governments/UTs that have not yet adopted Gender Budgeting;
- (e) whether the Government has conducted any study to assess the impact of adoption of Gender Budgeting, if so, the details thereof; and
- (f) the other steps taken by the Government to strengthen the Gender Responsive Budgeting in the country.

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) The Government of India has adopted Gender Budgeting in 2005-06 as a budgetary strategy to advance gender mainstreaming at the national and State levels with focus to translate gender commitments into budgetary commitments across all sectors. So far Gender Budgeting is being done by 37 Central Ministries by way of reconstitution of Gender Budgeting Cells and designation of nodal officers. Gender Budgeting has been adopted by 27 States/UTs.

(b) The funds released to national and State Government institutions during the last three years is as under:

- (c) The Gender Budget Statement (GBS) is a reporting mechanism to assess budgets which are being allocated for women and girls by different Ministries/Departments. For the Financial Year, 2021-22, an amount of Rs. 1,53,326.28 Cr. has been allocated for the women and girls by 43 Ministries/Departments/UTs. In this regard, an amount of Rs. 25,260.95 Cr. has been allocated under Part 'A' (100% women oriented schemes) and an amount of Rs. 1,28,065.33 has been allocated under Part 'B' (30-99% women oriented schemes) for Financial Year 2021-22.
