Will the Minister of Finance be pleased to state:

- (a) whether the Government allocates the share of central taxes for Union Budget Schemes to all the State Government;
- (b) if so, the details of allocated central taxes to the State Governments during the last three years, State-wise;
- (c) the amount of funds allocated to Rajasthan from the said funds during this financial year, head-wise; and
- (d) the details of allocated funds, Scheme-wise?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI ANURAG SINGH THAKUR)

- (a) Yes. The Union Government provides shares of Central Taxes and duties to State Governments as per the accepted recommendations of the Finance Commission in its award period.
- (b) The details of share of Central taxes & duties, State-wise and Year-wise are placed at 'Annexure-A'
- (c) & (d) The tax head-wise and financial year-wise details of share of Central taxes allocated to Rajasthan for all purposes including implementing schemes is as under:
