(a) whether the Government is aware of the amount of taxes collected on petrol, diesel and gas (Fuel) for both the Centre and State from the financial year 2013- 14 to 2019-20 and for the ten months from April, 2020 to January, 2021;

(b) if so, the details thereof;

(c) whether the taxes collected on petrol, diesel and gas, as a percentage on the Budget of the relevant years, have increased or decreased; and

(d) if so, details thereof for the years from 2014-15 to 2019-20 and for the ten months from April, 2020 to January, 2021?
