Projects under NIP

4320. PROF. SAUGATA RAY: SHRI DUSHYANT SINGH:

Will the Minister of Finance be pleased to state?

(a) the details and number of projects under the National Infrastructure Pipeline (NIP), ministry-wise;

(b) the details and number of projects completed so far under NIP and the projects which are pending at present along with the expected tenure for completion of these pending projects;

(c) the cost of each project and the details of amount disbursal that has taken place for the same, project-wise;

(d) the details of mechanism for fund disbursal and the time period/phased manner in which the fund has been disbursed to these projects;

(e) the details of the annual targeted and achieved expenditure of the projects under NIP, ministry-wise;

(f) the details of the progress of the projects under NIP along with sector-wise classification, State wise;

(g) the funding mechanisms undertaken by the Government and the amount of investment that has been mobilised by the Government under NIP along with the future funding mechanisms that the Government would undertake to fund projects thereunder; and

(h) whether the Government has any proposal to include more projects under NIP and if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN MINISTRY OF FINANCE (SHRI ANURAG SINGH THAKUR)

(a) to (h): NIP is a first-of-its-kind, whole-of-government exercise. For this purpose, a Task Force was constituted by the Hon'ble Finance Minister on 06.09.2019 which submitted its Report on 29th April 2020. This Task Force Report includes details of NIP projects, Ministry wise total project cost, annual target, etc. and is available in the public domain at:

The NIP is not a static pipeline but a dynamic pipeline of infrastructure projects in which projects and its details can be amended, added or deleted as per requirement of central ministries/departments/state governments, etc. NIP started with 6,835 projects and now increased to 7671 projects as on 17.03.2021. NIP projects with details including project completion status are in the public domain at <u>https://indiainvestmentgrid.gov.in/home</u> which is updated by the concerned central ministries/departments/state governments, etc.

NIP is not a scheme and therefore it is not having any project centric provision and mechanism for any fund or disbursal of any fund. The projects included in the NIP have been primarily proposed by concerned project authorities of Central Ministries/State Govts and it is for them to fund these projects through their budgetary/extra budgetary resources, innovative financing including selection of mode of implementation of the project whether EPC/PPP, etc.
