Will the Minister of Education be pleased to state:

- (a) the schools and educational centres set up under Samagra Shiksha Abhiyan (SSA) in Uttar Pradesh particularly in Pilibhit district during the last five years;
- (b) the details along with funds released for the purpose during the said period, district-wise and year-wise;
- (c) whether the Government proposes to establish more schools and education centres in Uttar Pradesh particularly in Pilibhit district under SSA keeping in view its backwardness; and
- (d) if so, the details thereof and if not, the reasons therefor?

ANSWER

MINISTER OF EDUCATION (SHRI RAMESH POKHRIYAL 'NISHANK')

(a) to (d): The Department has launched the Samagra Shiksha – an Integrated Scheme for School Education by subsuming the erstwhile Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE) from 2018-19. It is an overarching programme for the school education sector extending from pre-school to class XII and aims to ensure inclusive and equitable quality education at all levels of school education.

The schools sanctioned under erstwhile schemes of SSA & RMSA and Samagra Shiksha in Uttar Pradesh from the year 2015-16 to 2020-21 are as under: -

These plans are then appraised and approved/estimated by Project Approval Board in consultation with the States and UTs as per the programmatic and financial norms of the scheme.
