Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether export of major cereals like wheat and rice is on the rise during the last three years;
- (b) if so, the details thereof;
- (c) whether it is also a fact that their purchase from the farmers by Government agencies is also on the rise; and
- (d) If so, the details of such purchase from farmers during each of the three years including the current year, State-wise and agri-commodity-wise?

(a)&(b): The details of export of major cereals like Wheat and rice (basmati and non - basmati) during last three years indicate an increase in export of basmati rice during 2018-19 as against export in 2017-18 but a minor short fall in 2019-20. However, during current year 2020-21 both Wheat and non- basmati rice are showing significant increase in spite of pandemic.

The requisite details are annexed at **Annexure-I.**

(c)&d): The purchase of wheat and rice from farmers by Government agencies has increased from 2017-18 to 2019-20. The details of state wise procurement of Paddy/rice,

and Wheat during last three years and current year by FCI and NAFED are respectively at Annexure-II&III.
