Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) whether the foodgrains allocated for the poor is being distributed on time in all the States;
- (b) whether adequate number of godowns have been constructed by the Government for storage of the said foodgrains allocated for the poor in the country including in Chhattisgarh; and
- (c) if so, the details thereof, State-wise?

- (a): Targeted Public Distribution System (TPDS) is operated under the joint responsibilities of the Central and State/UT Governments. Inter-alia the operational responsibilities of distributing foodgrains to National Food Security Act (NFSA) beneficiaries lies with the respective State/UT governments. Whereas, this Department has issued the allocation order to all States/UTs as per the accepted coverage of beneficiaries under the Act for timely distribution to all NFSA beneficiaries through TPDS as per the distribution cycles followed by the States/UTs.
- (b)&(c): Requirement of storage capacity depends on the level of procurement, & offtake under National Food Security Act (NFSA) & Other Welfare Scheme (OWS). FCI assesses and monitors the storage capacity and based on any storage gap assessment, storage capacities are created/hired.

As on 28.02.2021, Storage capacity available with FCI and State agencies for storage of central pool foodgrain stock is 819.48 Lakh MT (Covered – 669.40 LMT and CAP – 150.08 LMT) against the stock holding of 577.78 Lakh MT.
