Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government has taken several steps/ launched a number of new schemes during the last six and a half years with an objective to increase the income of farmers by 2022;
- (b) if so, whether the Government has been successful in enhancing farmers' incomes as per the Swaminathan Commission report's recommendations;
- (c) if so, the details of the increase in farmers' income during the said period;
- (d) the average incomes of farmers during the last six years, State and year-wise;
- (e) whether Minimum Support Price (MSP) of various crops has witnessed a record increase during the last six and a half years leading to a record increase in the income of farmers as well; and
- (f) if so, the details thereof?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a): The Government has adopted several developmental programmes, schemes, reforms and policies, that focus on higher incomes for the farmers. All these policies & programmes are being supported by higher budgetary allocations, non-budgetary financial resources by way of creating Corpus Funds like Micro Irrigation Fund and Agri-marketing Fund to strengthen eNAM and GrAMs, Market Reforms like Model APLMC (Promotion & Facilitation)

Act, 2017, Establishment of 22,000 number of Gramin Agriculture Markets (GrAMs), Agri-Export Policy, The Farmers Produce Trade and Commerce (Promotion & Facilitation) Act., 2020, The Farmers (Empowerment & Protection) Agreement on Price Assurance and Farm Services Act., 2020, Amendments to Essential Commodities Act, 1955, Promotion of 10,000 FPOs and supplementary income transfers under PM-KISAN, Pradhan Mantri Fasal Bima Yojna (PMFBY), Pradhan Mantri Krishi Sinchai Yojna (PMKSY), Increase in Minimum Support Price (MSPs) for all Kharif & Rabi Crops, Har Med Par Ped, Bee-Keeping, Rashtriya Gokul Mission, Blue Revolution, Interest Subvention Scheme, Kisan Credit Card (KCC), etc. The latest major intervention includes the 'Atma Nirbhar Bharat – Agriculture' which includes comprehensive market reforms and creation of 'Agricultural Infrastructure Fund (AIF)' worth Rs. 1 lakh crores. In the Budget Announcement 2021-22, allocation to Micro Irrigation Fund has been doubled to Rs 10000 crore and Institutional Credit has been increased to Rs 16.50 lakh crore.

- (b): All the initiatives of the Government, led to higher production, increased MSP/procurement etc. Further income support through PM-KISAN etc is helping the farmers.
- (c) & (d): The last Situation Assessment Survey was conducted by NSSO in 2012-13.
- (e) & (f): The Government's price policy is to ensure remunerative prices to farmers by deciding MSP which is fixed at a pre-determined principle by keeping MSP at a level of one and half times of the cost of production. Accordingly, Government has increased the MSPs for all mandated Kharif, Rabi and other commercial crops with a return of atleast 50 percent over all India weighted average cost of production from agriculture year 2018-19. Comparative figures of 2013-14 vs 2020-21 is at **Annexure**.
