ASPIRATIONAL DISTRICTS

4730. DR. ALOK KUMAR SUMAN: SHRI RAM MOHAN NAIDU KINJARAPU:

Will the Minister of PLANNING be pleased to state:

- (a) whether 112 districts were chosen for the Aspirational Districts Programme (ADP) based through a transparent process on composite index, calculated using published and appropriately weighted data sets and if so, the details thereof;
- (b) the details of the works started in these districts in Bihar and the progress made so far thereunder;
- (c) the details of the total number of districts selected and the total amount sanctioned and released in this regard in Bihar;
- (d) the details of score of Srikakulam and Gopalganj district (Bihar) based on the same composite index;
- (e) the details of comparative score of Srikakulam and Gopalganj with the current score of the 112 districts selected for the ADP; and
- (f) the reasons for not including Gopalganj in the Aspirational Districts, which is one of the most backward district of Bihar and is adversely impacted due to floods?

ANSWER

(a) Yes Sir. Under the Aspirational Districts Programme, 112 districts, across 26 states and 1 union territory, were selected based on a Composite Index of backwardness created from the database in the public domain. Out of the 112 districts, 35 districts were recommended by the Ministry of Home Affairs on the basis of their being adversely affected by the Left Wing Extremism. The list of data sets and the weights attached to them for selection of districts is attached at *Annexure - I*. While selecting the districts, it was also ensured that at least one district is selected from every State (except for Goa) and many districts are not selected from the same State. After selection, the list was shared with the respective State Governments with a request to recommend any change based on any objective criteria. Subsequently, these were incorporated while finalizing the list.

- (b) The Aspirational Districts Programme being a governance measure for greater efficiency, large infusion of additional fund from Government of India, is not envisaged. The programme aims at effective convergence of the existing Centre and State Government Schemes, in these Districts through collaboration between Centre, State, District Administration and the citizens. Under the Programme, each Aspirational District is monitored on 49 indicators, entailing 81 data points, across 5 sectors - Health & Nutrition, Education, Agriculture & Water Resources, Financial Inclusion & Skill Development and Basic Infrastructure. However, in order to promote the spirit of competition between the Districts, Government of India implements a special initiative under which additional allocation is being provided to the Aspirational Districts on the basis of performance. Every month, districts are assessed on the basis of monthly incremental progress and the best performing Districts in overall terms and in each of the five sectors are identified. The first and second rankers in overall terms are awarded Rs. 10 cr and 5 cr respectively. The first ranker from each of the five sectors is awarded Rs. 3 cr each. Therefore, every month, Rs. 30 cr is utilised from the JICA funds and given to these Aspirational Districts. As on date, total around Rs. 230 crores has been sanctioned to 81 Aspirational Districts in FY 2019-20 and FY 2020-21 for undertaking projects across the five focus sectors and meeting critical gaps. This includes 7 districts in Bihar as given below under answer (c) The projects are under various stages of implementation.
- (c) Thirteen Districts were identified from the State of Bihar under the Aspirational Districts Programme. The list of these districts is attached at Annexure – II. The following districts in Bihar have been sanctioned additional allocation on the basis of their performance in monthly rankings:

(d) While shortlisting the Aspirational Districts, the districts of Srikakulam and Gopalganj did not fall within the 112 districts based on Composite index of backwardness. Based on data set available in Jan 2018, the overall ranking in terms of backwardness of Srikakulam was 9th among 13 districts in Andhra Pradesh and Gopalganj was 30th among the 32 districts in Bihar. Since 29 districts were relatively more backward than Gopalganj in Bihar, hence the district was not selected. No recommendation for

inclusion of Gopalganj district and Srikakulam district was received from the State Government.

- (e) After selection of districts, the Aspirational Districts Programme calculates and maintains ranking of only 112 Aspirational Districts. Ranking of other Districts are not calculated under the programme.
- (f) While Sitamarhi, Araria, Purnia, Katihar, Begusarai, Khagaria and Sheikhpura districts were chosen on the basis of their ranking in the Composite Index of Backwardness, the remaining six namely Aurangabad, Banka, Gaya, Jamui, Muzaffarpur and Nawada were also selected due to them being most affected by the Left Wing Extremism. As stated above, as per the available data sets enumerated in **Annexure-I** and their value as on January 2018, other districts were relatively poor performing than Gopalganj.
