- (c) whether the Government has received any demand for construction of FOBs and ROBs at Latehar, Barwadih, Tori and Chhipadohar railway stations in Jharkhand;**
- (d) if so, the details thereof and the action proposed to be taken by the Ministry in this matter; and**
- (e) if not, the reasons therefor?**

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF UNSTARRED QUESTION NO. 4735 BY SHRI SUNIL KUMAR SINGH TO BE ANSWERED IN LOK SABHA ON 24.03.2021 REGARDING FOBs IN JHARKHAND**

**(a): At present, there is no unmanned level crossing (UMLC) on Broad Gauge (BG) routes on Indian Railways. Only 948 UMLCs (Meter Gauge (MG)-308, Narrow Gauge (NG)-640) are existing on MG/NG routes.**

**(b): Details of new Railway Over Bridges (ROBs), Railway Under Bridges (RUBs) and Foot Over Bridges (FOBs) sanctioned during last three years and the current year along with allocation are as under:**

**(c) to (e): Demand has been received from an Hon'ble Member of Parliament for construction of 2 ROBs. The details are as under:**

**(i) ROB near Tori station at Chandwal-Dobhi path: This ROB is to be constructed by National Highway Authority of India (NHAI). General Arrangement Drawing (GAD) has been approved by Railway.**

**(ii) ROB near Latehar station at Latehar-Saryu path: ROB has been sanctioned by Railways. Planning activities have been taken up.**
