Allocation of Coal Mines to Private Sector

4749. SHRI CHUNNI LAL SAHU: SHRI MOHAN MANDAVI:

Will the Minister of *COAL* be pleased to state:

- a. the total number of allocations of coal mines in the private sector, company wise, year-wise, and State-wise;
- b. whether the process of the allocation of mines stated above and the process of allocation of 214 cancelled mines are different;
- c. if so, the details of the short comings noticed;
- d. if not, whether the Government is considering to cancel the said allocation; and
- e. if so, the details thereof?

<u>ANSWER</u> <u>MINISTER OF COAL, MINES & PARLIAMENTARY AFFAIRS</u> (SHRI PRALHAD JOSHI)

- a. 42 coal mines have been allocated to Private Sector under Coal Mines (Special Provisions) Act, 2015 (CMSP Act, 2015) and Mine and Mineral (Development &Regulation) Act, 1957 (MMDR Act, 1957). The list of mines may be found in the Annexure enclosed.
- b. Yes Sir. Under Coal Mine Nationalisation Act, 1973 the coal blocks were allotted through Screening Committee constituted for screening proposals for allocation of coal/lignite blocks for manufacture of iron/steel, captive production of power and production of cement in the public/private sector.

Whereas the allocation of 204 coal mines de-allocated by Hon'ble Supreme Court is now made through transparent & competitive bidding mechanism to private sector under the provisions of the Coal Mines (Special Provisions) Act, 2015 and Rules made thereunder.

- c. No short-comings have been noticed so far.
- d. No, Sir. Government is not considering the cancellation of said allocation.
- e. Does not arise in view of reply above.
