#### **SETTING UP OF INDUSTRY**

Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state: वाणिज्य एवं उद्योग मंत्री

- (a) whether any Industry is being set up at Banda and Chitrakoot districts including Bundelkhand of Uttar Pradesh;
- (b) if so, the details and locations thereof;
- (c) the time by which the said industry is likely to be established; and
- (d) if so, the reasons therefor?

#### **ANSWER**

# वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्री सोम प्रकाश) THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI SOM PARKASH)

(a): As per information received from Department of Industries, Government of Uttar Pradesh, a total number of 3,146 MSMEs have been established in Banda district and 4,372 MSMEs have been established in Chitrakoot district till 30.06.2020. In Bundelkhand region, total 27,886 MSME units have been established. Further, total 26 MOUs have been signed for Bundelkhand region. The progress of 13 MOUs is as given: 05 industrial units in Jhansi district (4 MSME and 1 Heavy) have started commercial operations; 05 (4 MSMEs and 1 Heavy) are under various stages of implementation in Jhansi (2), Lalitpur (2) and Jalaun districts and likely to be completed by December 2023; and 03 units in Chitrakoot (1) and Hamirpur (2) categorized as heavy are likely to be completed by 2023. The remaining 13 MoUs have shown intent to invest but no progress has been informed.
