**(a) & (b) : Government of India had launched "Integrated Power Development Scheme" (IPDS) in December, 2014 with the aim to provide quality and reliable power supply in the urban areas with the following components:**

- I. Strengthening of sub-transmission and distribution network in urban areas.**
- II. Metering of feeders / distribution transformers/consumers in urban areas.**
- III. IT enablement of distribution sector and strengthening of distribution network being undertaken under R-APDRP (Restructured Accelerated Power Development and Reforms Programme) as subsumed component.**

**The IPDS scheme has a total outlay of Rs. 32,612 crore, including a budgetary support of Rs. 25,354 crore from the Government of India for new projects in addition to the total outlay of Rs. 44,011 crore, including budgetary support of Rs. 22,727 crore under subsumed component of RAPDRP. New projects, worth Rs 31,203 crore have been sanctioned in 547 circles of 33 States/UTs and Rs. 14,605 crore has been disbursed. The State/UT-wise details including Maharashtra are furnished at Annexure-I.**

**(c) : Under IPDS, Central funding is being provided for strengthening of sub-transmission & distribution networks in the urban areas and metering of distribution transformers/feeders/ consumers for reduction of Aggregate Technical & Commercial (AT&C) losses. Funds have also been sanctioned under IPDS for underground (UG) cabling and Aerial Bunched (AB) cables.**

**(d) : The details of completion of works in Maharashtra are furnished at Annexure-II.**
