Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government has set any targets under the Pradhan Mantri Awas Yojana (PMAY) and if so, the details thereof:
- (b) the actual achievements made against the targets thereunder during each of the last three years, State-wise; and
- (c) the details regarding total fund allocation made and spent under the yojana during the said period?

ANSWER

- (a): In pursuance to Government's vision of 'Housing for All' by 2022, the Ministry of Housing and Urban Affairs (MoHUA) has been implementing Pradhan Mantri Awas Yojana Urban (PMAY-U) Mission since June 25, 2015 to assist States/Union Territories (UTs) both technically and financially in providing all weather pucca houses with basic civic infrastructure to all eligible urban households by year 2022. Against the validated demand of 1.12 crore houses across the country, so far, 1.11 crore houses have been sanctioned under the four verticals of PMAY-U Mission. Out of the sanctioned houses, more than 75 lakh houses are in various stages of construction, and over 43 lakh houses have been completed.
- (b) & (c): The State/UT-wise details of houses sanctioned, completed and year-wise completion during each of the last three years along with Central Assistance released and utilised under PMAY-U Mission are at Annexure.
