PUBLIC PROCUREMENT POLICY FOR MSEs

547. SHRI JAYANT SINHA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be please to state:

- (a) the objectives of the Public Procurement Policy for Micro and Small Enterprises (MSEs);
- (b) the total annual procurement from such MSEs, sector-wise, category-wise (buyers), and year-wise during the last three years; and
- (c) the total annual procurement from such MSEs in Jharkhand along the same parameters?

ANSWER

(a): The Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 has been notified by this Ministry, under Section 11 of MSMED Act, 2006, the same being effective from 1st April, 2012, and has become mandatory w.e.f. April 2015. The policy was amended vide Gazette Notification No. S.O. 5670(E), dated 9th November, 2018. The said Policy, as amended, mandates 25% annual procurement from MSEs by Central Ministries/ Departments/ Central Public Sector Enterprises (CPSEs) including 4% from MSEs owned by SC/ST and 3% from MSEs owned by Women entrepreneurs.

(b): As per information reported by Central Public Sector Enterprises (CPSEs) on MSME SAMBANDH Portal, the details of the annual procurement of goods and services from MSEs, by CPSEs and year-wise during the last three years (as on date 01.02.2021) is given as under:
