Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of various works as well as schemes along with the amount of funds allocated by the Union Government during the last two year 2018-2020 to Chhattisgarh;and**
- (b) whether the Union Government has received any proposal sent by the Government of Chhattisgarh during the said period and if so, the details thereof?**

ANSWER

(a) The Ministry of Housing and Urban Affairs(MoHUA) facilitates and assists States/Union Territories (UTs) through its flagship Missions/Schemes - Atal Mission for Rejuvenation and Urban Transformation (AMRUT), Smart Cities Mission (SCM), Pradhan Mantri Awas Yojana (Urban)(PMAY-U), Swachh Bharat Mission-Urban(SBM-U), Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) in urban development. The Mission/Schemes are implemented by the States/UTs in accordance with the Mission guidelines. MoHUA extends financial assistance for the schemes/projects as per guidelines. Details of Mission/schemes, works and amount released to Chhattisgarh are given in the Annex I and Annex II respectively.

(b) Proposal for sanction of 1, 35,192 houses under PMAY-U was received during the period from the Government of Chhattisgarh which was approved.

AnnexI referred to in reply to Part (a) of Lok Sabha Unstarred Question No 554 regarding 'Allocation of funds for Chhattisgarh'

(i) Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

Atal Mission for Rejuvenation and Urban Transformation (AMRUT) was launched on 25 June, 2015 in 500 mission cities with focus on water supply, sewerage & septage management, storm water drainage, green spaces & parks and non-motorised urban transport. Under the Mission individual projects are selected, appraised approved and implemented by the concerned States/Union Territories (UTs) themselves. The Government of India only approves State Annual Action Plans (SAAPs) and releases Central Assistance (CA) as per Mission guidelines. For Chhattisgarh SAAP envisaging investment of ₹2,192 crore with committed CA of Rs. 1,009.74 crore for its 09 Mission cities has been approved. Against this, contracts for 292 projects costing Rs.2,299.81 crore have been awarded including 208 projects worth Rs.502.84 crore which have been completed.

(ii) Smart Cities Mission

The Government of India launched Smart Cities Mission (SCM) on 25 June 2015 for developing 100 cities as Smart Cities. The objective of the Mission is to promote cities that provide core infrastructure and give a decent quality of life to its citizens, a clean and sustainable environment and application of 'Smart Solutions'. A total number of 100 cities have been selected to be developed as Smart Cities under the Smart Cities Mission. The implementation of the Smart Cities Mission at the city level is done by a Special Purpose Vehicle (SPV) created for the purpose. The SPVs plan, appraise, approve, implement, manage, operate, monitor and evaluate their Smart City projects.

Raipur, Bilaspur and Atal Nagar are the three cities selected under the Smart Cities Mission in the State of Chhattisgarh. The current status of projects being carried out by Smart Cities in Chhattisgarh is given in table below.

(iii) Swachh Bharat Mission (SBM-U)

Swachh Bharat Mission-Urban was launched on 02.10.2014 with the objective of improving the sanitation in the Urban Local Bodies (ULBs) by achieving 100 per cent Open Defecation Free (ODF) status and by 100 percent scientific processing of Municipal Solid Waste (MSW) generated in ULBs. The details of works executed in Chhattisgarh from the funds released to the State during the last two years 2018-2020 is not maintained in the Ministry since the work is executed by the concerned State Government/Union Territory (UT) in various Urban Local Bodies (ULBs) after release of funds to the State Government.

(ii) Pradhan Mantri Awas Yojana-Urban (PMAY-U)

PMAY(U) extends Central Assistance to States/Union Territories (UTs) including State of Chhattisgarh for providing all weather pucca houses to all eligible urban households, especially Economically Weaker Section (EWS) families/beneficiaries, by the year 2022, through the following four verticals:

- (i) “In-Situ” Slum Redevelopment (ISSR);
- (ii) Credit-Linked Subsidy Scheme (CLSS);
- (iii) Affordable Housing in Partnership (AHP); and
- (iv) Beneficiary-led individual house construction or enhancement (BLC).

Out of the above mentioned, four verticals, CLSS is being implemented as a Central Sector Scheme. In the State of Chhattisgarh, 2,62,615 number of houses have been sanctioned out of which 1,24,123 number of houses have been completed. An amount of Rs.4036.95 crore has been sanctioned as a total central assistance, out of which 2071.27 crore has been released.

Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY-NULM)

The Deendayal Antyodaya Yojana - National Urban Livelihood Mission (DAY-NULM) covering all statutory towns in the country aims to reduce poverty and vulnerability of the urban poor households by enabling them to access self-employment and skilled wage employment opportunities, resulting in an appreciable improvement in their livelihoods on a sustainable basis. The mission also aims to build strong grassroot level institutions of the urban poor; provide shelters equipped with essential services to the urban homeless and address livelihoods concerns of the urban street vendors by facilitating access to suitable spaces, and institutional credit. The primary target of DAY-NULM is urban poor, including urban homeless and particular emphasis is laid on mobilisation of vulnerable sections of urban population such as SCs/STs, minorities, female-headed households, persons with disabilities, destitute, migrant labourers and especially vulnerable occupational groups such as street vendors, rag pickers, domestic workers, beggars, construction workers etc.
