HEALTHCARE CENTRES IN BIHAR

714. DR. ALOK KUMAR SUMAN:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) the number of healthcare/CGHS centers functional in Bihar particularly in Gopalganj district;

(b) the number of such centres sponsored by Union and the State Government, separately;

(c) the details of staff, doctors and nurses posted at all the healthcare /CGHS centres, district-wise in Bihar;

(d) whether the Government has any scheme to establish more healthcare/CGHS centres in Bihar particularly in Gopalganj district; and

(e) if so, the detail thereof and if not, the reasons therefor?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY)

(a) to (e): "Public Health & Hospitals" being a State subject the primary responsibility for ensuring healthcare services including establishing more public health care facilities lies with respective State Government.

However, to address the healthcare challenges, particularly in rural areas, the National Rural Health Mission (NRHM) was launched in 2005 to supplement the efforts of the State/UT governments to provide accessible, affordable and quality healthcare to all those who access public health facilities. Currently, NRHM is a sub-mission of National Health Mission (NHM).

NHM support is provided to States/ UTs for setting up of new facilities as per norms and upgradation of existing facilities for bridging the infrastructure gaps and to fill up the vacancies of Human Resource on contractual basis based on the requirement posed by them. Similarly, the establishment of new CGHS centres at new location from time to time depends on the established norms like number of CGHS beneficiaries subject to availability of resources. At present, there is no such proposal under consideration.

Rural Health Statistics (RHS) is an annual publication, based on Health care administrative data generated by the health care system. RHS provides information on rural health infrastructure and requirements of public health facilities in rural areas as reported by States. As per the RHS 2019, the District-wise details of the availability of health centres in Bihar including Gopalganj District may be seen at **Annexure-1**.

Further, there are total 09 Central Government Health Scheme (CGHS) Wellness Centre in Bihar which is sponsored by the Central Government. Details the Information regarding the manpower in CGHS Centres may be seen at **Annexure-2**.

As per the RHS 2019, the Information regarding the Health Manpower in the State of Bihar may be seen at **Annexure-3**.
