- (c) whether the Government has observed any lack of adequate usage of the funds divulged for the welfare and development projects; and
- (d) if so, the actions taken thereon?

(a): The details of amount of funds allocated under the scheme of Special Central Assistance to Tribal Sub-Scheme SCA to TSS) during last five years is given below:
