Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) whether in the name of Covid-19 more than lakhs of private companies have been shut down during the last 6 months;
- (b) if so, the details of closed units and new companies registered during April 2020 to June 2021, State-wise;
- (c) the number of unemployment registered and losses incurred reported thereto; and
- (d) whether the Government proposes to assess the facts and reality in this regard and if so, the details thereof along with the action taken/proposed to be taken in this regard?

(a) and (b): The Ministry of Corporate Affairs (MCA) administers the provisions of the Companies Act, 2013 (the Act), the Limited Liability Partnership Act, 2008 and the Insolvency and Bankruptcy Code, 2016.

The term of "shut down" or "closed unit" is not defined under the Act. However, during April 2020 to June 2021 name of total 16527 number of Companies were struck off from the register of Companies pursuant to the provisions of section 248 of the Act.
