#### EMPOWERMENT OF TRIBAL WOMEN

#### †115. SHRI MANOJ KOTAK:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether the Government has launched any scheme to empower tribal women;
- (b) if so, the details thereof; and
- (c) the number of tribal women benefitted under the scheme, State-wise?

#### **ANSWER**

# MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

(a) to (c): The Government has adopted a holistic approach for overall development of tribal population, including tribal women, by providing support, inter alia, for education, health, employment, agriculture, horticulture, animal husbandry, sanitation, drinking water, skill development and livelihood. The Ministry of Tribal Affairs has been implementing schemes/programmes with focused approach on the socio-economic development of the Scheduled Tribes (STs), including tribal women, in a coordinated and planned manner. The schemes/ programmes being implemented by the Ministry of Tribal Affairs for the development and welfare of Scheduled Tribes in the country is given at Annexure 1. The National Scheduled Tribes Finance and Development Corporation (NSTFDC), under the Ministry of Tribal Affairs, is implementing an exclusive scheme titled "Adivasi MahilaSashaktikaran Yojana (AMSY)" for economic development of Scheduled Tribes Women. Under the scheme, NSTFDC provides loan upto 90% for projects costing upto ₹2.00 lakh. Financial assistance under the scheme is extended at highly concessional rate of interest of 4% per annum. State-wise number of beneficiaries women assisted under AMSY is given at Annexure 2.
