Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government proposes to establish new food processing units and food parks in the country especially in Gujarat during the period 2021-22,;
- (b) if so, the details thereof along with the current status of such units, State-wise especially in Uttar Pradesh;
- (c) whether the Government has selected some districts/regions for these units/food parks, if so, the details of the selected regions; and
- (d) whether the Government has earmarked any budget for the said project, if so, the details of the budget earmarked therefor?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) to (d): Ministry of Food Processing Industries(MoFPI) does not set up food processing units and food parks on its own. However, it has been implementing a central sector umbrella scheme – Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) for overall growth and development of food processing sector of the country. PMKSY is not region or state specific but demand driven and is implemented across the country including in the state of Gujarat and Uttar Pradesh. Under its component scheme - Creation / Expansion of Food Processing & Preservation Capacities scheme, MoFPI provides grants-in-aid to entrepreneurs for setting up of food processing units, whereas under the Mega Food Parks scheme and Infrastructure for Agro Processing Clusters scheme, it provides grants-in-aid for setting up of Mega food Parks & Agro Processing Clusters respectively. Proposals for financial assistance are invited through Expression of Interest (EoI) under these component schemes. The state-wise status of projects approved, including in the state of Gujarat and Uttar Pradesh, and Budgetary Estimate (BE) for 2021-22 for these component schemes is placed at Annexure-II respectively.
