PRODUCTION OF POULTRY AND DAIRY INDUSTRIES

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) the estimated production of milk, milk products, egg and poultry meat during the last three years;
- (b) whether the production of poultry and dairy industries in the country is showing a declining trend;
- (c) if so, the details thereof and the reasons therefor;
- (d) whether the Government has taken any steps to adopt the latest scientific developments in modernisation of these industries, if so, the details thereof along with the current demand and supply of poultry products, milk and milk products in the country; and
- (e) the steps taken by the Government to increase production of poultry, milk and milk products in the coming years?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

- (a) The estimated production of Milk, Egg and Poultry Meat during the last three years as in Annexure-I. The estimated production of milk products during last three years are not available with the department.
- (b) The production of poultry (in terms of egg and meat production) and dairy (in term of milk production) industries in the country is showing an increasing trend over the three years.
- (c) Not applicable.
- (d) & (e) The Government has taken up the following steps to adopt the latest scientific developments in modernisation of poultry and dairy industries as well as to increase the production of poultry, milk and milk products in the coming years.

The Department of Animal Husbandry and Dairying is implementing Centrally Sponsored Scheme Rashtriya Gokul Mission (RGM) for development and conservation of indigenous bovine breeds since December 2014. Under the Scheme, several scientific technologies have been made accessible to the

farmers such as sex sorted semen (for production of female calves with 90% accuracy), IVF technology for production of animals with high genetic merit at a faster rate and genomic selection. The scheme is important in enhancing milk production and productivity of bovines and to meet growing demand of milk and making dairying more remunerative to the rural farmers of the country. The scheme is leading to multiplication of elite animals of indigenous breeds and increased availability of indigenous stock.\

The Department is implementing National Programme for Dairy Development (NPDD) across the country since Feb-2014 with an objective of creating/strengthening of infrastructure for production of quality milk, procurement, processing and marketing of milk & milk products by the State Implementing Agency (SIA) i.e. State Cooperative Dairy Federations/ District Cooperative Milk Producers' Union. This year, the scheme has been restructured and from 2021-22 to 2025-26 the focus will be on quality improvement with installation of bulk milk coolers and strengthening of milk testing facilities for State Cooperative Dairy Federations/ District Cooperative Milk Producers' Union/SHG run private dairy/Milk Producer Companies/Farmer Producer Organisations.

The Central Sector Scheme Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDCFPO) was launched during 2017-18. The scheme is being implemented by National Dairy Development Board (NDDB). Main objective of the scheme is to assist the Cooperative Societies and farmer producer organizations engaged in dairy activities by providing soft working capital loan to tide over the crisis on account of severely adverse market conditions or natural calamities. Due to Economic Impact of Covid-19 on Dairy Sector, Ministry of Fisheries, Animal Husbandry and Dairying has introduced a new component "interest subvention on Working capital loans for Dairy sector" as one of the component with an outlay of Rs 20 Crore for 2020-21. Temporarily, the other component namely "working Capital loan" was kept in suspension during 2020-21. As on 02.07.2021, NDDB have conveyed sanction of Interest Subvention amount of Rs 150.58 Crore against working capital loan amount of Rs 10588.64 Crore @ 2% p.a. and released Rs 71.63 Crore as interest subvention amount.

Dairy Processing and Infrastructure Development Fund (DIDF) scheme is being implemented by the department with objective of Creation/ strengthening of Milk Processing, Value addition & chilling facilities with total outlay of Rs. 11,184 Crore including loan outlay of Rs 8004 Crore; NABARD disburse loan to NDDB/ NCDC which is then disbursed by NDDB /NCDC to End Borrowers. GoI provide 2.5% interest subvention to National Bank for Agriculture and Rural Development (NABARD). As on 31.05.2021 40 projects in 11 states has been approved with total outlay of Rs 4957 Crore. Out of this amount loan component is Rs. 3381 Crore. Till 30.5.2021, Rs.1157 Crore. Loan has been disbursed to End Borrowers and Interest subvention released by GoI to NABARD is Rs. 54.59 Crore.

National Animal Disease Control Programme for control of Foot & Mouth Disease and Brucellosis (NADCP) is a Central Sector Scheme, with an outlay of Rs 13,343 Crore for five years and was launched by Hon'ble Prime Minister on 11th September, 2019. The programme aims to control FMD and Brucellosis by 2025 with vaccination and eventual eradication of FMD by 2030. The FMD results in a reduction of milk production which is a direct loss to the farmers. So far around 17 crores of cattle and buffalo has been vaccinated against FMD in the country.

Poultry sector in India is divided into highly organized commercial sector. 80 % of the total market share is organized commercial sector and the rest is unorganized. The organized commercial sector contributing 80 % is already modernized and technically improvised. However, Department of Animal Husbandry & Dairying, is implementing "Entrepreneurship development and employment generation" (EDEG) under NLM Under which, a component called, Poultry Venture Capital fund (PVCF) for which includes credit cum subsidy linked activities is implemented through NABARD. Under this component

establishment of composite Backyard Poultry unit having parent farm, mother unit and Hatchery unit can be established.

Further, to increase the Poultry production under National Livestock Mission financial assistance is provided to States/ Union Territories Governments for implementation of Rural Backyard Poultry Development (RBPD) and Innovative Poultry Productivity Project (IPPP). These programmes envisage the components which take care of the shelter, feed, medicine, equipments, litter etc. to improve the living conditions of the Poultry birds.

Also for increasing the production of Poultry products and Dairy Products Department of Animal Husbandry and Dairying (DAHD) is implementing Animal Husbandry Infrastructure Development Fund (AHIDF) of Rs 15000 crores which was announced under Honorable Prime Minister's Atma Nirbhar Bharat Abhiyan stimulus package. The Animal Husbandry Infrastructure Development Fund (AHIDF) has been approved for incentivizing investments by individual entrepreneurs, private companies, MSME, Farmers Producers Organizations (FPOs) and section 8 companies to establish (i) the dairy processing and value addition infrastructure, (ii) meat processing and value addition infrastructure and (iii) Animal Feed Plant.
