CONSTRUCTION OF ANGANWADI CENTRES UNDER MGNREGS

1302. SHRI SANJAY SETH:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether construction of Anganwadi Centres under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is permissible;
- (b) if so, the number of Anganwadi Centres constructed under MGNREGS in the State of Jharkhand during the last five years and the current year, year-wise and district-wise; and
- (c) the number of Anganwadi centres that the Ministry is planning to construct during the current year and in 2021-22 in the State of Jharkhand, district-wise?

(a) & (b) As per Para 4 (I) of the Schedule-I of the Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA), construction of buildings for Anganwadi Centres is permissible under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS). Year-wise and district-wise details of Anganwadi Centers constructed under Mahatma Gandhi NREGS in the State of Jharkhand during the last five years and the current financial year 2021-22 (as on 22.07.2021) is given at **Annexure-I**.

(c) Mahatma Gandhi NREGS is demand driven wage employment programme with bottom up planning. The Ministry does not plan or set any target for any specific work (including Anganwadi Centres) under the Scheme for any States/UTs. The Gram Panchayat is responsible for identification of works in the Gram Panchayat area to be taken under the scheme as per recommendations of the Gram Sabha, and for executing and supervising such works. Number of Anganwadi Centers ongoing districts-wise (as on 22.07.2021) is listed at **Annexure-II**.
