IMPLEMENTATION OF PMFBY

1334 SHRI THOMAS CHAZHIKADAN:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) whether the Pradhan Mantri Fasal Bima Yojana (PMFBY), that aims to provide financial support to farmers suffering crop loss/damage arising out of natural calamities, is fulfilling its unique objective of stabilizing the income of farmers through crop insurance;

(b) if so, the details thereof, State/UT-wise along with the relevant details of total number of beneficiaries in Kerala in the financial year 2020- 21, district- wise; and

(c) whether any significant steps are being taken to address the anomalies on the implementation side, if so, the details thereof.

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) & (b): Yes Sir. The Pradhan Mantri Fasal Bima Yojana (PMFBY) is successfully fulfilling the objectives of the schemes including providing financial support to stabilize income of farmers especially in natural calamity hit seasons/years to ensure their continuance in agriculture. Since inception of the scheme in 2016-17, against premium of Rs. 21614 crore paid by farmers, claims of Rs.97719 crore have been paid to 834.6 lakh farmer applications. Year-wise and State/UT-wise details of Number of farmer applications enrolled, sum insured, farmers premium, gross premium, claims paid and number of farmer applications to whom claims paid since inception of the scheme till 2019-20 are given in **Annexure-I**. District-wise details of number of farmer applications enrolled, hence eligible for benefit of premium subsidy in Kerala during 2020-21, are given in **Annexure-II**.

(c) : The revisions/improvements in the crop insurance schemes is a continuous process. Based on the experience gained, views of various stakeholders and with a view to ensure better transparency, accountability, timely payment of claims to the farmers and to make the scheme more farmer friendly, Government has comprehensively revised and revamped the Operational Guidelines of the Pradhan Mantri Fasal Bima Yojana (PMFBY) with effect from Rabi 2018 and Kharif 2020 respectively to ensure that the eligible benefits under the scheme reach the farmers in time.
