- (a) & (b) BharatNet, a project to provide broadband services in Rural India, is being implemented in a phased manner to reach all the Gram Panchayats (GPs) in the country. The State/UT-wise details of the Service Ready Gram Panchayatsand GPs which are yet to be made Service Ready under BharatNet project, are given in **Annexure-I.**
- (c) & (d) For Haryana, the District-wise details of the Service Ready Gram Panchayats, and the GPs which are yet to be made Service Ready under BharatNet project, are given in **Annexure-II.**
