Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether National Urban Digital Mission (NUDM) and several digital initiatives have been launched recently for transforming urban governance and if so, the details thereof;
- (b) the details of objectives of these digital initiatives;
- (c) the manner in which these initiatives would support all urban local bodies in the country and deliver on the promise of serving all citizens;
- (d) whether a large number of projects under Smart Cities Mission are not working in accordance with their schedules and their sanctioned cost has also overrun;
- (e) if so, the details of various such projects, city-wise; and
- (f) the corrective steps taken by the Government for timely completion of such projects?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a) to (c) Yes, Sir. TheNational Urban Digital Mission (NUDM), along with other initiativesincluding, *inter alia*, India Urban Data Exchange (IUDX), Smart Code Platform, and City Innovation Exchange (CiX) have been recently launched by the Ministry of Housing and Urban Affairs (MoHUA) for transforming urban governance. The objectives & expected deliverables of these initiatives are given in <u>Annexure-I</u>.
- (d) to (f) No. Sir. Government of India launched the Smart Cities Mission (SCM) on 25 June 2015 for development of 100 cities as Smart Cities. The selection of 100 Smart Cities has been completed through 4 rounds of selection from January, 2016 to June, 2018. The cities under SCM have shown considerable progress since their selection. As on 9 July 2021, these cities have tendered out 6,017 projects worth ₹ 1,80,873 crore; out of which work orders have been issued in 5,375 projects worth ₹ 1,49,251 crore; out of these, 2,781 projects worth ₹ 48,150 crore have been completed. There has been more than 260% growth in projects tendered and more than 380% growth in projects grounded/completed in the last three years. Government of India has released ₹ 23,925.83 crore as the Central share to the States/Union Territories out of which ₹ 20,410.14 crore (85%) has been utilized by the Smart Cities. The Smart Cities are expected to complete their projects within 5 years from their date of selection. The Smart Citywise status of projects is given in Annexure-II.
