- (c) whether the Government is aware that the various projects are pending due to non-sanction of bank loans; and

(a) to (d): The projects/schemes of Government are reviewed regularly. However, currently projects /schemes of Government are under review for their continuation in the 15<sup>th</sup> Finance Commission cycle as per Ministry of Finance guidelines. These inter alia include Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Technology Centre Systems Programme (TCSP), Credit Linked Capital Subsidy Scheme for Technology Upgradation (CLCS-TUS), Procurement and Marketing Support (PMS), Scheme of Funds for Regeneration of Traditional Industries(SFURTI).
