**Encroachment on forest land**

1851. SHRI NIHAL CHAND:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the area of land reserved for forest cover in the country;
- (b) whether any assessment has been made by the Government regarding encroachment on the said land;
- (c) if so, the details thereof;
- (d) the steps taken by the Government to vacate the encroached land; and
- (e) whether the State Governments have been directed to take action in this regard and if so, the details thereof?

**ANSWER**

- (a) As per the India State of Forest Report (ISFR), 2019, the total Recorded Forest Area in the Country is 7,67,419 square kilometre. The State/Union Territory (UT) wise details including Haryana are given in **Annexure-I**.
- (b) to (e) As per the information received from States /UTs, the State/UT wise details of the forest area under encroachment in the country are given in **Annexure-II**.

Since, protection and management of forests is primarily the responsibility of concerned State/UT, whenever any complaint regarding encroachment is received, the same is forwarded to the concerned State or UT for taking appropriate actions as per the extant acts, rules and regulations. The States and UTs also take various measures such as demarcation and digitization of forest boundaries, strengthening infrastructure for forest protection, involving fringe area forest communities such as Joint Forest Management Committees, Eco Development Committees etc. to prevent and control encroachments. The Ministry has written to State Governments/UT Administrations to remove encroachment and ensure that no further encroachment takes place as per the existing Acts/rules.
