THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SMT. DARSHANA JARDOSH)

(a) & (b): With a view to create a robust human resources for the textiles sector, particularly the need for trained and skilled workforce in all segment of the textiles sector, Ministry of Textiles has implemented various skill development schemes and programmes since the financial year 2010-11. Under the comprehensive Integrated Skill Development Scheme(ISDS), a total of 11.14 lakh persons have been trained during FY 2010-11 to 2017-18, in various diverse segments of textiles covering textiles and apparel, jute, spinning, weaving, technical textiles, sericulture, handloom and handicrafts of which 8.43 lakh persons have been employed.

In further continuation, Ministry of Textiles has extended the skill development programme in the form of Samarth-Scheme for Capacity Building in Textile Sector for a period upto 2023-24 with the objective to provide demand driven, placement oriented National Skills Qualifications Framework (NSQF) compliant skilling programmes to incentivize and supplement the efforts of the industry in creating jobs in the organized textile and related sectors, covering the entire value chain of textiles, excluding Spinning and Weaving in organized sector. The COVID-19 pandemic has impacted the implementation of the scheme adversely. Training programme for about 3.3 lakh beneficiaries allocated to various implementing partners after due process of empanelling and physical verification of training centres is progressing at various stages. State-wise details of progress of training programme under Samarth scheme is given at **Annexure-I**. State-wise list of training centres under Samarth is given at **Annexure-I**.

(c): There is no state-wise allocation of funds under Samarth and the cost of training programme is released directly to implementing partners. The details of funds allocated and released under Samarth scheme during the last three financial years is as follows:

(d) & (e): Ministry, during 2018-19, have invited proposals from all the State Governments for partnering under the scheme. A total of 18 State Government agencies have entered into Memorandum of Understanding (MoU) with Ministry for participation in the training programme under Samarth. No State government agency from Maharashtra has signed MoU for undertaking training programme under Samarth. In addition, the Government has partnered with 92 textile industries, 10 industry associations and 4 sectoral organizations of Ministry of Textiles for training programme under Samarth.
